OUR RATING METHODOLOGY FOR PICKING TRIAL COURT JUDGES

The decisions made by Florida's judges reach far beyond the courtroom. They shape how our laws are interpreted, how our constitutional freedoms are protected, and how justice is administered for generations to come. While judges do not write laws, they play a profound role in applying them—and those decisions can have lasting consequences for life, family, religious liberty, parental rights, and the rule of law.

Yet judicial elections are often the most difficult races for voters to navigate.

Unlike candidates for legislative or executive office, judicial candidates are ethically restricted in what they can say about many issues that may come before the courts. As a result, many voters either leave these races blank or cast votes with little reliable information. Despite these challenges, electing principled, high character, talented, respected, and worldview aligned jurists has never been more important.

That is why Florida Family Action has produced this guide.

As Florida's only statewide judicial voter guide from a Biblical worldview, this resource is designed help voters better understand the judicial candidates who will appear on their ballots by gathering publicly available information through a careful and consistent review process.

Our extensive vetting process focuses on four areas: character and virtue, judicial philosophy, legal experience and background, and any evidence, large or small, of biblical worldview alignment (or opposition) on life, marriage, family, and religious liberty. To evaluate each, our team researched campaign websites, candidate statements, news articles, past rulings and cases, endorsements, disciplinary records, church affiliations, social media and other sources of reputable insight, in addition to consulting with regional allies.



Our ENDORSEMENT rating (E): FFA has high confidence this candidate is not just better than the alternatives, but genuinely well-qualified to serve — in character, competence, and worldview alike.



Our PREFERRED rating (P): This candidate (or candidates) stands out as the stronger option relative to others in the race, but falls short of the bar for endorsement — whether due to limited information, mixed qualifications, or a close field where two candidates are difficult to distinguish between.
